Interim Guideline for Management of Solid Waste Generated by Households and Places under Self-Quarantine due to COVID-19 Outbreak


This Ministry has prepared the above guideline for the management of solid waste generated due to COVID- 19 outbreak.

The task of preparing this detailed guideline was performed by a team of experts comprising of Senior Officials representing relevant stakeholder institutions namely; Ministry of Health and Indigenous medical services, National Solid Waste Management Support Center of Ministry of Public Administration, Home Affairs, Provincial Councils and Local Government, Central Environmental Authority, as well as some distinguished subject matter experts such as Prof. Ajith de Alwis Senior Professor University of Moratuwa and Dr. Anurudda Karunarathna, Senior Lecturer, University of Peradeniya. Officials of this Ministry undertook the overall coordination of this activity while providing their input as well.

I have been informed that the team has studied related guidelines issued by World Health Organization, International Solid Waste Association as well as several other governments including Japan, China, South Korea, India and European Union in this task. The guideline is already being officially submitted to Ministry of Health and Indigenous Medical Services.
