

Assessment of New Environmental Friendly Innovations Presidential Environmental Awards - 2022

Application Guidelines

(School Children, University or Tertiary Education Centre/ Open Categories)

Eligible Applicants

Students from schools (Government, Semi Government, Private), Technical Colleges, other Tertiary Education Centers, Universities and all citizens of the country who has been developed new innovations on environmental aspect are eligible for the competition.

Categories of the competition

- School Category
- University and Tertiary education centers category
- Open category

School Category

- Students from Grade 9 to 13 with the maximum age limit of second attempt at the A/L examination are eligible to apply.
- For group innovation, maximum number of school children will be three (3)
- All the applicants in a group innovation should be school children and school children are not eligible to apply under other two categories.

University and Tertiary Education Centre Category

- Applicant should be a under graduate of a university or an internal student of a tertiary education centre or technical college.
- For group innovation, maximum number of students will be three (3)

Open Category

All other innovators except above two categories are eligible to apply under the open category.

General guidelines for the applicants

- All new innovations should be self-innovations and should not be a redevelopment of another personal property. In any incidence if you win a prize for such a redevelopment of another person's property, it is legally declared that you are bound to return all the prizes and certificates to the Central Environmental Authority.
- Applications should be dully filled and complied with the guidelines provided by the Central Environmental Authority.
- Separate application should be submitted for each innovation.
- Applications should be sent to the Director, Research and Development Unit, Central Environmental Authority, No. 104, Denzil Kobbekaduwa Mawatha, Battaramulla on or before 15/02/2022 indicating "Application for Environmental Friendly New Innovations" at the top left corner of the envelope.
- The dully filled word document of the application should be sent to the e-mails of ajithr@cea.lk & tamasha@cea.lk
- The information of the activities done relevant to the innovation within 2019-2021 years period should be submitted.
- The Gold awardees of National Green Awards / Presidential Environmental Awards in year 2019 are not eligible for apply in year 2022.

Evaluation

The best innovations will be selected by a committee appointed by the Central Environmental Authority. You are bounded by the final decisions taken by the committee.

- Any New Innovation (product) related to Environmental Conservation and Management.
